


# Unrelated Donor Registries and Public Cord Blood Banks

- More than 60 adult donor registries world-wide
  - More than 18 million adult donors
- More than 100 public cord blood banks
  - More than 500,000 cord blood units
- For nearly half (48%) of all unrelated donor transplants, the donor and the recipient are in different countries



## History



Early WMDA recommendations focused on the roles of the national "hubs" (i.e., registries) whose responsibilities are:

- (1) to process **incoming requests** for access to their donors/units arriving from hubs in other countries,
- (2) to facilitate **outgoing requests** for international donors/units for their national patients
- (3) to **coordinate the activities** of donor, harvest and transplant centers and cord blood banks within their country.

In 2004, formal standards were drafted and adopted

#### Summary:

World Marrow Donor Association standards are aimed at enhancing the quality of unrelated volunteer donor hematopoietic stem cell registries assisting transplant physicians in the international search for unrelated donors for their patients. The standards cover: (1) general organization of registries; (2) donor recruitment; (3) donor characterization; (4) information technology; (5) facilitation of search requests; (6) second/subsequent donations; (7) collection/processing/transport of stem cells; (8) follow-up of patient/donor; and (9) financial/

#### I. OVERVIEW AND DEFINITIONS

The WMDA Standards are aimed at enhancing the quality of Registries and assisting transplant teams in their searches for international donors and cord blood units

The Standards promote high quality procedures necessary to obtain, in the shortest possible time, the appropriate quality and quantity of hematopoietic stem cells for a recipient while protecting the anonymity, health, and well-being of the unrelated donors.
